NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. BY SIGNING THIS AGREEMENT, YOU GIVE UP YOUR RIGHT TO BRING A COURT ACTION TO RECOVER COMPENSATION OR OBTAIN ANY OTHER REMEDY FOR INJURIES TO YOURSELF OR YOUR PROPERTY ARISING OUT OF YOUR USE OF EAST ALABAMA GUN CLUB, LLC. NOW OR ANY TIME IN THE FUTURE.

I acknowledge that I am over the age of twenty-one (21) years. I, and on behalf of my heirs, agents, assigns, beneficiaries, executors and administrators, state that I understand that the activity that I have chosen to participate in (and/or observe) at East Alabama Gun Club, LLC. (hereinafter "EAGC") is very hazardous in that loaded firearms and weapons are discharged not only by myself but also by other EAGC Members, guests and visiting public. I agree to read and abide by all the EAGC Range Rules & Regulations, and also I agree to assume any and all risks associated to and with the use of the facilities, including but not limited to: participation in EAGC sponsored events, and the use and discharge of firearms, accidental discharge of firearms, and loss of personal property through misplacement, loss or theft while at EAGC.

I, and on behalf of my heirs, agents, assigns, beneficiaries, executors and administrators, for the consideration of being allowed to enter and use the facilities and services of EAGC, and to observe the shooting competitions, and for other valuable considerations, do hereby absolutely and unequivocally agree to release, save and hold harmless EAGC, the Officers and Directors and Members of EAGC, its sponsors, agents, employees, instructors, assigns and successors in interest from any claim, demand or liability (whether claimed by myself or another person or entity) which may arise out of any loss, damage, injury or death which I may sustain, as well as any theft, unexplained disappearance or damage which may befall my property accompanying me (whether while en route to, during participation in or during observation of the event(s), and while en route from the event, or while on the EAGC premises) where any of the match events occur, with the above use of facilities and services. **I VOLUNTARILY ASSUME ALL SUCH RISKS FOR MY FAMILY MEMBERS, GUESTS AND MYSELF (and heirs, agents, assigns, beneficiaries, executors and administrators).**

I, on behalf of myself and all family members, agree to indemnify and hold harmless EAGC, the Officers and Directors and Members of EAGC, its agents, employees, instructors, assigns and successors in interest for any and all damages caused by my use of the EAGC facilities and discharge of firearms which would include, but not be limited to, damages or personal injuries caused by my negligence and / or the negligence of minors that I have brought to EAGC, or by the negligence caused by other persons, and attorney fees and costs to defend any and all claims brought against EAGC, the Officers and Directors and Members of EAGC, its agents, employees, instructors, assigns and successors in interest.

I further acknowledge the right of EAGC Officers or Range Officers to immediately terminate my participation in activities upon any failure of mine (or my guests) to fully comply with all EAGC Rules and Regulations and directions of the Range Officer. I hereby state that I am under NO legal injunction that prohibits my owning, possessing, handling or using any of the firearms used in the events at EAGC.

By my signature below, I certify that I have read, understand and agree to the terms and conditions of this Release and Waiver and the EAGC Range Rules & Regulations. I also agree that I (and any minors and guests brought with me) will - at all times within the EAGC Range Property - wear appropriate eye and ear protection. It is intended that this Release and Waiver be valid for all visits to East Alabama Gun Club, LLC. upon my signature of this document for now and any time in the future.

I acknowledge that the foregoing agreement is intended to be as broad and inclusive as permitted by the law of the State of Alabama and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. I understand that the terms of this agreement are legally binding and that I am signing this agreement, after having carefully read it, of my own free will.
